The Order made by the Minister for Local Government under Sections 438M and 438O of the Local Government Act 1993 expires on 29 April 2021. It is appropriate that steps be taken to transition back to an elected Council.

In my 30 day Interim Report I stated that Central Coast Councillors had not come to terms with the fundamental role of their position and their functions under the Local Government Act. In my 3 Month Progress Report I noted that changes have been implemented to see Central Coast Council return to a strong financial position over the next five years or so.

It will be imperative that Councillors, should they return to office, understand their role and also understand the systems that have been implemented to achieve good financial outcomes.

To facilitate this, I will be inviting all Councillors to attend two briefings. I would expect those suspended Councillors committed to the future of the Central Coast, and their role in it, to make all possible efforts to attend.

Below are further details. I note that it may be necessary to slightly amend the time or location due to logistical reasons.

Financial Briefing

A financial briefing will be conducted on Tuesday 30 March 2020 in the afternoon. The briefing will be conducted in person only, but in accordance with Council's COVID safe plan.

The purpose of this briefing will be to give an overview of the financial situation and actions taken to date. Councillors will also be presented with examples of monthly reports that will be implemented for the information of Councillors and the community.

Tuesday, 30 March 2021 – 4pm – Wyong Administration Building

Meeting with CEO

All Councillors will be invited to meet newly appointed Chief Executive Officer, David Farmer on the afternoon of Thursday, 15 April 2021.

This will be an informal meeting and will be conducted in person.

A strong working relationship between Council and the CEO will be vital to the future of Central Coast Council and its success.

Title: Administrator's Minute - Question for Referendum

At the meeting held 3 February 2021, Council resolved as follows:

- 1 That Council resolve to conduct a Constitutional Referendum for the reduction of Councillors (from 15 to 9) in conjunction with the September 2021 Local Government Elections.
- 2 That Council undertake community consultation to include: whether to reduce the ward structure from 5 to 3; have no wards; maintain the status quo with 15 councillors and 5 wards, and provide a report back to Council before mid April 2021.
- 3 That Council request the Acting Chief Executive Officer to notify the NSW Electoral Commission of this Administrator's Minute and resolution within 21 days as required under Schedule 10 of the Local Government (General) Regulation 2005.
- 4 That Council settle the proposed Constitutional Referendum question and provide this wording to the NSW Electoral Commission before mid April 2021 for the election.
- That Council make provision in the 2021/22 budget for the additional costs of the NSW Electoral Commission running a Referendum in conjunction with the September 2021 Local Government Elections and the cost of Council fulfilling its obligations in relation to the explanatory material.

In response to the resolution of Council, the NSW Electoral Commission was advised of Council's intent to conduct a Referendum in conjunction with the 2021 Local Government election.

In addition, Council undertook community consultation as resolved.

Report

As part of my 30 Day report into the Central Coast Council's financial I formed the view that that fifteen Councillors is too many for the effective operation of a Council. I stated that this large number does not facilitate collaborative and effective decision making, and often results in an adversarial environment which does not benefit the Central Coast Community.

As a result, I resolved that a referendum be held at the September 2021 Local Government Election to reduce the number of Councillors from 15 to 9.

To pass, the question would need to be supported by a majority of Central Coast electors. Should the referendum be passed, the changes would take effect for the next local government election for the Central Coast to be conducted in 2024.

Consultation was undertaken on two issues being:

- 1 Reduction of Councillors
- 2 Ward structure

The consultation report is attached.

1 Reduction of Councillors

In response to the consultation, the 78% of 613 survey participants wanted to reduce the number of Councillors from 15 to 9.

As a result, I plan to proceed with a Referendum question to reduce the number of Councillors from 15 to 9.

2 Change in Wards

It is a requirement that there be an equal number of Councillors elected from each Ward where a ward structure is in place.

Prior to determining this question for the referendum, community consultation was conducted to ascertain community sentiment on whether to reduce the Wards from five to three or abolish wards..

Section 16 and Section 210 of the Local Government Act 1993 provides that if the Council proposes to alter, abolish or change the number of wards it must conduct a Referendum. Should it be determined through the Referendum that the wards should be reduced, then the boundaries will be changed in accordance with Section 210A of the Local Government Act 1993.

The process for determining the revised ward boundaries includes the Council ensuring there is no greater than 10% difference in electors between any two wards (based on Census Collection Districts and approved by the NSW Electoral Commission), public exhibition of proposed ward boundaries for not less than 28 days, accepting submissions on proposed ward boundaries for not less than 42 days and consideration of submissions received prior to making a determination. This process would be undertaken should the Referendum be passed and twelve months before the following local government election.

In response to the community consultation 55% of 465 survey participants wanted to abolish Wards and have all Councillors represent the whole Central Coast.

Potential question

The deadline to submit final wording for any question is 12noon on the closing date for the election in accordance with Clause 4(b), Schedule 10 of the Local Government (General) Regulation 2005 which is 4 August 2021. However, the NSW Electoral Commission has requested the wording be submitted as soon as possible but prior to the end of June 2021.

The Office of Local Government issued a Circular to Councils on 30 November 2020 regarding Constitutional referendums. In that circular the OLG advised that:

It is of critical importance that the referendum question or questions are carefully framed to ensure that workable decisions are achieved. All questions put at a referendum should be clear, concise, and capable of being responded to with a 'yes' or 'no' answer. If more than one referendum question is being asked on a particular subject, then extra care needs to be taken to ensure that the possible combinations of 'yes' and 'no' answers do not produce a conflicting decision.

The following wording is proposed for the conduct of the Referendum:

Do you favour a reduction in the number of Central Coast Councillors, from fifteen to nine, and the removal of wards? This will result in nine Councillors with all electors voting for all nine Councillors, and all nine Councillors representing the whole Central Coast.

Advice on the efficacy of the question has been sought and obtained from Local Government NSW who advise that should the question receive the majority of votes it will result the abolition of wards with a reduction in Councillors from 15 to nine.

Consultation

The attached report details the consultation undertaken and the results.

Financial Considerations

The most cost-effective way of conducting this Referendum is that it be held in conjunction with the September 2021 Local Government Elections, as oppose to a standalone Referendum.

The cost of a Referendum has been estimated by the NSW Electoral Commission as 10% of the costs of the Local Government Election, when run at the same time as an ordinary Election.

At this stage the NSW Electoral Commission has indicated that the costs to run the September 2021 Local Government Election for the Central Coast is \$2,147,083. The additional cost of the Referendum would be \$214,700 and will need to be budgeted for. This additional cost is based on one question being asked.

Council is also responsible for the preparation and publicity of the required explanatory material for the Referendum (which Council must ensure presents a balanced case both for and against any proposition to be put). It is proposed that \$15,000 be allocated in the 2021/22 Budget for this purpose.

I formally move:

1 That Council resolve to conduct a Constitutional Referendum in conjunction with the conduct of the 2021 Local Government Election as follows:

Do you favour a reduction in the number of Central Coast Councillors, from fifteen to nine, and the removal of wards? This will result in nine Councillors with all electors voting for all nine Councillors, and all nine Councillors representing the whole Central Coast.

2 That Council advise the NSW Electoral Commission of the Referendum question.

Engagement Summary



Summary

In response to a resolution of Council on 3 February 2021 between 1 March and 15 March 2021 Central Coast Council's administrator Dick Persson AM sought community feedback on a Constitutional Referendum for the reduction of Councillors (from 15 to 9) in conjunction with the September 2021 Local Government Elections.

The consultation provided an opportunity for the community to submit feedback on the options proposed, which will help Council understand community sentiment on how the numbers may be reduced in order to finalise the proposed referendum questions.

We presented the community with an information package and invited them to participate in an online poll.

Engagement Results

Participants were asked if they would like Councillors reduced from 15 to 9:

Do you want Councillors reduced from 15 to 9?

78% Yes

22% No (status quo to remain)

(613 participants total)

Those that selected yes to a reduction in Councillors were then asked to let us know what their preferences for ward structure was:

Reducing Councillors from 15 to 9 requires a change in the Ward Structure. Please let us know which of the following options you prefer:

45%

5 Wards reduces to 3 Wards

55%

Abolish the Wards, 9 Councillors represent the whole Central Coast

As of Monday morning, it is clear this major storm event will repeat the flooding of many of the homes damaged last year. This will be heartbreaking for so many people who are barely over what happened only 13 months ago.

In terms of The Entrance channel, our acting CEO, Rik Hart, has been directing operations. Two Directors, Mr Cox and Mr Bolgoff, along with expert council staff, have been on the ground since last Thursday. Machinery has been in place and used as necessary. I continue to receive regular updates.

I have been impressed with the commitment and expertise of Council staff. I have no doubt they know what they are doing, and that everything was and is being done to minimise the impact of the weather.

Given the importance of this issue to so many people I have decided it is worth spending a small amount to engage an international expert to review our policy and approach to managing the channel.

Understandably public confidence in Council has been damaged with the events of the last few years.

An independent expert review by Mr Angus Gordan, Australia's leading coastal engineer, former head of Manly Hydraulics, former General Manager of Pittwater Council, will restore some of that confidence.

It is anticipated the review will result in either an endorsement or recommendation for change and will be available next week.

I formally move:

- 1 That Council engage Mr Angus Gordon, Australia's leading coastal engineering expert to undertake a peer review of Council's policy and approach in managing floods, particularly looking at the February 2020 flood event and flooding experienced in the past 4 days.
- 2 That Council note this review will be undertaken immediately and a report will be released publicly when it arrives.

Council adopted a structure on 30 November 2020 which incorporates the following positions:

- Director Water and Sewer
- Director Community and Recreation Services
- Director Environment and Planning
- Director Infrastructure
- Director Corporate Affairs

Since adopting the structure there has been commentary that Council no longer has a Chief Financial Officer.

The Local Government Act requires that a Council have a Responsible Accounting Officer. As defined by the legislation a responsible accounting officer, in relation to a council, means a member of the staff of the council designated by the council as its responsible accounting officer or, if no such member of staff is designated, means the general manager of the council.

At Central Coast Council the Director, Corporate Affairs is the Responsible Accounting Officer. The role, when advertised, required relevant qualifications and identified that the role is accountable for ensuring a focus on the financial sustainability and financial leadership of the organisation.

However, to give the community confidence and to provide visibility that there is a role performing the functions of a Chief Financial Officer I propose to amend the title of Director, Corporate Affairs to Director, Corporate Affairs and Chief Financial Officer.

I am making this change in accordance with section 333 of the Local Government Act which provides that the organisation structure may be redetermined from time to time.

I formally move:

That Council determine, pursuant to s. 333) of the Local Government Act 1993, that the position of Director, Corporate Affairs will be retitled to Director, Corporate Affairs and Chief Financial Officer.

Report purpose

To seek formal approval to write off \$20M of Internally Restricted Reserves pertaining to the following funds, in order to contribute towards the reimbursement of approximately \$200m of restricted reserves debt:

- \$10,000,000 Land Development Reserve
- \$4,701,646 Infrastructure Reserve
- \$316,223 Water Safety and Surf Clubs Reserve
- \$182,662 Kibble Park Café Reserve
- \$4,799,469 Waste Disposal Facility Reserve

Executive Summary

The Administrator's 30 Day Report in December 2020 identified that the extent of Council's accumulated debt is \$565m, made up of approximately \$365m of projected commercial debt as at 30 June 2021 and approximately \$200m of restricted reserves debt as at 30 June 2020 in the General and Drainage Funds.

It has been proposed that this restricted reserves deficit, be reimbursed as follows:

- Approx \$100m-\$110m from Council's budgeted surpluses over the 10 years, starting from 2021/22;
- Approx \$40m-\$60m from the sale of Council's property assets;
- \$20m-\$40m from the write-off of reserves that can be unwound and
- Commercial loan in the 10th year for any remaining restricted debt balance.

Detailed reviews of internally restricted reserves have identified instances where funds are either no longer necessary to support community needs or are in excess of the amount required to meet community needs.

Management recommends the write-off of \$20m of internally restricted reserves for the purpose of contributing to the reimbursement of the \$200m of restricted reserves debt.



Corporate Affairs Recommendation

- 1 That Council provide approval for the write-off totalling \$10,000,000 pertaining to the Land Development Reserve.
- 2 That Council provide approval for the write-off totalling \$4,701,646 pertaining to the Infrastructure Reserve.
- 3 That Council provide approval for the write-off totalling \$316,223 pertaining to the Water Safety and Surf Clubs Reserve.
- 4 That Council provide approval for the write-off totalling \$182,662 pertaining to the Kibble Park Café Reserve.
- 5 That Council provide approval for the write-off totalling \$4,499,469 pertaining to the Waste Disposal Facility Reserve.

Background

On 12 May 2016, the former Wyong Shire Council (WSC) and the former Gosford City Council (GCC) amalgamated to become Central Coast Council (CCC). At that time both WSC and GCC had in existence externally and internally restricted funds to cover employee leave entitlements, public liability insurance and numerous other funds to support community infrastructure. Since amalgamation a number of these internal reserves have been identified as no longer necessary to support community needs or in excess of the amounts required to meet community needs.

Current Status

At the time of writing this report, the following internally restricted reserves were determined to have funding in excess of current and expected requirements:

The following statement is provided in response to this resolution of Council.

The \$20M write-off of internally restricted reserves will result in the reduction of the total restricted balance, thereby reducing the unrestricted debt that Council has to reimburse.
